



ASSOCIATE MEMBERSHIP: Is geared towards local artists who do not have a large body of work to qualify for an exhibiting membership or are not currently able to have an exhibiting membership space in the shop due to similar items already being sold by current shop members. Local artists who want to promote their handmade work through having a link on the Bellefonte Arts website are welcome to apply.

Bellefonte Arts brings customers to our website through social media posts, local calendar listings, paid advertisements, participation in the Wilmington Art Loop, and Bellefonte Arts events throughout the year, including our annual Bellefonte Arts Festival and events hosted by the Shops of Bellefonte.

Annual membership for associate members is \$75.00 per year and would renew automatically via the Bellefonte Arts Square payment subscription service. You may cancel your subscription at any time, but there will be no refund as you are agreeing to pay for 1 year for a link on our website.

As a group of volunteers, we will be updating the Associate Membership webpage by the 28th of each month, so your link will be active on the website for a year from that date.

Artist applications are accepted via Google Form. Your submitting the google form and signing up through purchasing your 1 year membership through the Bellefonte Arts Square payment subscription link is your agreement to having your information listed on our website.

Membership benefits would include:

- Inclusion on our associate members directory webpage including name, photo and link to artist's website or social media site.
- Art Loop group exhibition opportunities at BA.
- Social media features.
- Use of #BAAssociateMember.
- 20% commission to BA for teaching classes (non-members pay 30% to BA).
- Discount on table fees for our summer shop and stroll events.
- Link in our email newsletter to assoc directory webpage.

MEMBERSHIP TERMINATION

If you cancel your subscription before the end of your 1 year renewal, your membership will end at the 1 year date and your information will be removed from our website. If you no longer want your information on our website before the end of your annual membership date, you must give written notice via email for us to remove your information from the website immediately (it may take us as few as a couple of days, up to 30 days).

BELLEFONTE ARTS reserves the right to terminate artists' Membership at its discretion, for any and all reasons, and with or without advance notice. It is our discretion if a membership refund will occur at a pro-rated amount for any terminated artists.
